## How to leave a gift in your Will

You'll want to make sure that your loved ones are taken care of first, but you may also decide that you'd like to leave a gift to a charity such as Lymphoma Action.

Whatever the size of your legacy, it will make a big difference. We are extremely grateful to everyone who chooses to leave us a gift in their Will.

#### There are three ways you can leave a gift in your Will to support people affected by lymphoma:

### 📌 A cash gift

You can choose to give a fixed amount of money, known as a pecuniary gift.

## A percentage of your estate

You can choose to leave a share of what is left in your estate after you have provided for your family and friends, known as a residuary gift.

### 🛠 A specific gift

You can leave an item or items of value such as jewellery, artwork, buildings or land. This also includes investment shares as they don't have a fixed financial value. Whatever type of gift you choose to leave, please make sure you include our charity name, address and charity number to ensure that the legacy is valid:

## **Carol's story**

Carol Taylor was diagnosed with non-Hodgkin lymphoma in 1985. The support she received from Lymphoma Action made such a difference to her, and she chose to leave a gift to the Charity in her Will.

Her sister Lynne tells us more:

"Carol wanted to give something back to Lymphoma Action after the support they had given her for more than 20 years. She got involved in fundraising, taking part in a swimathon, music event, and even writing a poetry book.

In 2019 we both took part in Lymphoma Action's Bridges of London walk. For Carol, this was a tremendous achievement, as she had myelodysplasia (disrupted bone marrow function) at the time, following many rounds of chemotherapy and a failed stem cell transplant. Together, we completed the seven-mile route and it was such a great feeling! Carol went on to remember the Charity in her Will, and she loved knowing that her gift would support other people affected by lymphoma in the future."

Carol passed away in 2020. Her legacy will help Lymphoma Action be here for everyone affected by lymphoma. In Carol's words:

"I hope my efforts will enable many more people to benefit from their knowledge, care and comfort".



## Why should I make a Will?

Having an up-to-date Will is the only way to make sure that your loved ones, and any charities or organisations you care about, are provided for in the way that you wish after your death. Without a Will, the law decides who gets what and how much.

# Is making a Will expensive or difficult?

Making a Will need not be expensive or difficult. To find a solicitor in your area, visit The Law Society website: LawSociety.org.uk

# What if I want to amend an existing Will?

A solicitor can assist in making a change to an existing Will by adding a codicil. This needs to be signed and witnessed in the same way that a Will is. Do not make changes to your existing Will without professional legal help as you may accidentally render it invalid.

## What about tax?

Gifts in Wills to Lymphoma Action are exempt from inheritance tax. Currently inheritance tax on non-charitable bequests above the threshold of £325k is charged at 40%, but is reduced further if you give more than 10% of the net value of your estate to charity. The threshold can vary over time and more information can be found on the HMRC website: gov.uk/Make-will
